CAUSE: ROOTS EST OVERFLOW VOLUME: 140 GAL
UPON ARRIVAL, THE WSSC INSPECTOR FOUND MANHOLE 081U OVERFLOWING AT 1GPM, ONTO THE PAVEMENT, AND INTO THE GRASSY AREA AROUND THE MANHOLE. WHEN THE JET CREW ARRIVED, THE MANHOLE WAS NO LONGER OVERFLOWING. THE CREW JETTED FROM MANHOLE 080M TO 081U A TOTAL OF 200', AND HIT AND RELIEVED A ROOT BLOCKAGE AT 50', TO END THE EVENT.

STEPS TAKEN OR PLANNED TO REDUCE, ELIMINATE AND PREVENT RECURRENCE:
THE PROBLEM WITH THIS SEWER LINE HAS BEEN REFERRED TO LINE BLOCKAGE ANALYSIS (LBA) FOR REVIEW. A FOLLOW-UP INVESTIGATION WILL BE CONDUCTED TO DETERMINE WHAT MEASURES SHOULD BE TAKEN TO REDUCE OR ELIMINATE THE CHANCE OF THIS LINE OVERFLOWING AGAIN.

MEASURES INITIATED/TAKEN TO MINIMIZE IMPACT:
FLUSHED BACK INTO MANHOLE VISIBLE SOLIDS REMOVED

THE CREW SPREAD LIME IN THE GRASSY AREA AROUND THE MANHOLE.
