- To act as Construction Manager (Resident Engineer) on WSSC Water projects.
- To perform the following activities to include, but not limited to:
  - Project meetings
  - Documentation
  - Submittals review and processing
  - Quality Control
  - Change Order Review
  - Assist with negotiations
  - Inspections as necessary
- To document all project activities and confirm that it meets the specification requirements.

This contract will provide Construction Management Services as needed to perform requested activities associated with water and wastewater facilities construction through a Basic Ordering Agreement contract.

Activities will include:

- Preconstruction services
- Construction services
- Post-construction services
- Other design, engineering, and construction services may be required by WSSC Water

WSSC Water intends to award multiple contracts to qualified Construction Management Services firms. Selected firms can not perform construction management services on WSSC Water projects in which they or any of their major sub consultants participated in the planning or design process.

The contract term will be 7 years with no option term.

It is WSSC Water's intention to award multiple contracts to qualified design engineering firms.

Selected firms will not be performing construction management services on WSSC Water projects in which they or any of their major sub consultants participated in the planning or design process.

Contract term will be 7 years with no option term.



# Keys to Success

- Work is completed as required in the task schedule.
- Task cost is within budget.
- Minimum or no scope changes on the task.
- Quality Control - Quality of work meets the contract requirements.
- Open communications with WSSC managing and inspection staff.
- Provide the proper resources for each task.
- Address problems within a reasonable time.
- Documentation for project activities.



# Contract Compliance

# Contract Compliance

- Submit monthly invoices.
- Maintain minority business percentages
- Address task orders in a reasonable time as stated in the contract.
- Perform task order scope of work.
- Assure the contract is completed within the specified time.
- Assure approved materials are installed on the project.
- Assure quality standards are met in all activities.
