CAUSE: DEBRIS EST OVERFLOW VOLUME: 702 GAL UPON ARRIVAL, THE CREW FOUND MANHOLE 002M OVERFLOWING APPROXIMATELY 3 GPM, ONTO THE GRASSY AREA AROUND THE MANHOLE, AND INTO A NEARBY CREEK IN THE WESTERN BRANCH BASIN. THE CREW JETTED FROM MANHOLE 117U THROUGH MANHOLE 002M, AND RELIEVED A RAGS OBSTRUCTION AT 376', TO END THE EVENT.
